LEGISLATIVE AFFAIRS INFORMATION

After numerous delays and extra meetings, I am happy to report that a final version for the Kansas Council of Classified Senates' Position Paper FY'04 is done. A copy of that document can be found on page 2. If you happen to have seen the earlier draft on our website, you will notice that there are some changes. However, the basic issues and priorities remain the same.

This year the Legislative Information Day will occur on Tuesday, February 4th. Although the budget situation remains grim and we know it will be a difficult persuasion effort, there are reasons to have hope.

First and foremost, it appears for the first time in many years of doing this we will have some help and support from the various University Administrations. In our case, the office of EVC for University Relations, Janet Murguia. The corresponding officers at the other Regents' schools seem willing as well. Historically, state employees at agencies where top administration has been vocal in support of their needs, have fared better in their wage treatment by the Legislature.

Another positive is that we may have more inroads than ever before into the Administration. S.E.A.C., the State Employee Advisory Committee, now exists to provide a regular open channel. We have been able to get information about our needs and concerns into the hands of one of Governor elect Sebelius' policy advisers, who happens to be a Lawrence resident. Two other Lawrence people, Troy Findley and Rod Bremby, have been appointed to important roles in the new administration.

Additionally, although our issues remain basically unchanged from those in the past, we have some new approaches to presenting them that we hope will prove more persuasive.

Finally, we hope that the hard times that have descended upon us will prompt more of you than ever before to make your voices heard in record numbers. Write letters to your Senator and Representative, asking for their support of the issues on our position paper, particularly those related to salary needs. (If you are one of those whose net paycheck has gone down, it is very important for you to make your dissatisfaction known.) Ask your friends and family, especially those

who live in areas of the state where there are not major concentrations of state agencies, to do the same. [Editor's note: Names and addresses can be found on page 3 of this newsletter.]

As always, you can get your letters into the hands of any Classified Senator by January 31st, and we will see that they get delivered.

CIVIL SERVICE ALTERNATIVE

On October 21, the Communications and Personnel Committees of Classified Senate met with Provost David Shulenberger, Vice Provost Lindy Eakin, and Director of Human Resources Ola Faucher to discuss classified employment.

The Provost is interested in re-pursuing the issue of KU's classified employees leaving the State's Civil Service system and becoming University of Kansas or Regent employees in a similar way to that of faculty and/or unclassified staff. Also, at the two Town Hall meetings organized by the Provost to discuss Tuition Enhancement funds, many of the classified employees present expressed support for this change.

Such a change would give KU more autonomy over its employees. One thing in which the Provost is particularly interested is the ability to offer merit pay increases to classified staff in a fashion comparable to how KU currently determines these for faculty and unclassified staff.

A task force has been formed to discuss what such a change might entail. The members of that task force are Mike Auchard, Lindy Eakin, Ola Faucher, Linda Fund, Kathy Jansen, Eleanor Kent, Bette Luther, and Beverly Koerner. The group has begun regular discussions about this issue. Classified Senate and University Administration will distribute more information as the process evolves.

KANSAS COUNCIL OF CLASSIFIED SENATES FY04 POSITION PAPER

Representing over 6,000 classified employees in the Regents System

Emporia State University, Fort Hays State University, Kansas State University, Pittsburg State University, University of Kansas, Wichita State University

Salary

- adjust pay matrix annually so lowest pay rate is above most current Federal Poverty Salary Guidelines for a family of four
- fund pay matrix step increases
- □ fully fund longevity pay at the current rate and remove \$1,000.00 cap
- establish standing guidelines to keep Classified Employees salaries equitable with private sector

Benefits

- fund any increase in health insurance premiums by an offset of appropriated dollars to Regents Universities
- □ increase Sick Leave earned per pay period from 3.7 to 4.2 hours
- increase Annual Leave earned per pay period by .5 hours and remove cap
- subsidize health insurance premiums for retirees with 85 points, specifically those that choose to retire before they are eligible for federal assistance

Retirement

- reduce KPERS vesting period to five years
- □ close the unfunded retirement liability gap in KPERS

We support the initiatives of the State Employee Advisory Committee (SEAC) on behalf of all state Classified Employees.

TUITION ASSISTANCE

SUMMER SEMESTER DEADLINE IS 5:00 p.m., FRIDAY, APRIL 11TH

The Tuition Assistance program is available to staff with six months of KU employment. The program normally covers tuition for one class per semester. Classes should be structured courses that meet on a scheduled basis with days and times published in the Timetable of Classes. The tuition assistance application form is available on the Human Resources website under forms download. For more information, contact Lynn George, at 864-7415. Applications should be

forwarded to the Tuition Assistance Committee, c/o Human Resources, 103 Carruth-O'Leary Hall.

Please note: when you are filing out your form, fill in the amount of tuition to the best of your ability. Once tuition rates are set, the amount will be adjusted accordingly on your application.

Important Tax Update: In the past, pursuant to IRS requirements, tuition assistance was considered a taxable benefit for individuals with at least a baccalaureate degree and was reflected accordingly on the employee's annual W-2 form. Beginning with the Spring 2002 semester, awarded tuition assistance for both undergraduate and graduate courses will be excluded from gross income. This exclusion for employer-provided tuition benefits has been expanded and extended through December 31, 2010 by the Economic Growth and Tax Reconciliation Act of 2001.
